Merge onto I-20 W. Take the SC-6 exit- EXIT 55- toward LEXINGTON / PELION. Keep RIGHT at the fork to go on SC-6 / S LAKE DR. Turn LEFT onto ROBERTS ST. ROBERTS ST becomes GIBSON RD. End at 299 Duffie Dr Lexington, SC 29072
